ASRS UPDATE BY STEVE RAMOS



New survey shows the value of an Arizona State **Retirement System Pension to public educators.**

In 2020/2021, the ASRS completed a new survey targeting ASRS Active members. The intent of the survey was to better understand their perception and understanding of the

ASRS. Active contributing members play a critical role in the ability of the ASRS Pension Plan to guarantee a lifetime benefit for all retirees. On July 1st 2021, Actives will begin paying the new contribution rate for employees of 12.41%, which is matched by their ASRS employer.

SURVEY RESULTS:

- Only 63% of Actives understand the difference between a defined benefit and a 401k style defined contribution plan.
- 82.3% of Actives say the lifetime retirement benefit was influential in their decision to work and stay with an employer that contributes to the ASRS. Actives also overwhelmingly would recommend a job to a friend or family member, with an ASRS employer.
- 84.3% of Actives believe their retirement is secure
- 79.3% feel the current contribution rate is affordable.
- 80% of Actives believe ASRS acts ethically and 78% believe ASRS acts in their best interests.

Overall, the Actives' Survey indicates that as a member works longer and gains a better understanding of ASRS benefits, their positive perception of the ASRS increases. ASRS plans to work to enhance the educational materials targeted to new members and members with five to ten years of service.

2021 LEGISLATION: As a result of legislation passed this session, ASRS looks forward to being able to selfinsure ASRS health plans for next year. Becoming selfinsured will save on the cost of health care administration and is expected to shave a few dollars off premiums in 2022. At the writing of this report, a bill (HB2138) which would have allowed Arizona's university employees to opt out of the ASRS pension plan and would have created new liability costs to the ASRS Plan, appears to be dead. However, AEA Retired will continue to monitor it until the legislature adjourns sine die.

YEAR-END NUMBERS: Since the new fiscal year began on July 1, 2020, market returns year-to-date have been good. A recent report from ASRS shows the total fund hovering around \$46 billion and an estimated yearto-date return on investment of around 22%. If that return number holds up through June 30th of 2021, the rate of return over a two-year period would exceed the ASRS expected yearly rate of return for the fund of 7.5%. There is no expectation of a Permanent Benefit Increase (PBI) in the near future. However, AEA Retired continues to talk about legislative options that could provide for a real Cost Of Living Adjustment (COLA). Unfortunately, unless the 2022 election brings a change in political control of the legislature, the chance of a COLA is still unlikely.

AEA-Retired Annual Meeting and AEA Delegate Assembly again held virtually for 2021

Ninety-eight AEA-Retired members gathered around their computers, iPads, or cell phones to attend the 33rd AEA-Retired Annual Meeting held virtually on May 7th. The four-hour meeting was packed with interesting, informative guest speakers, election of officers, break-out sessions, and drawings for cash prizes.

Led by Anna Cicero, AEA-Retired President, the meeting moved efficiently and was. During the morning session, Julie Cieniawski, who ran unopposed for the position of Vice President, was declared the winner by acclamation by Elections Chair-

person, Steve Linder. Attendees then heard brief remarks from the nine candidates who were seeking a position as a Member-at-Large on the AEA-Retired Board. The eighty-five attendees who were also delegates to the AEA Delegate Assembly, then voted electronically for their choices. Winning seats on the Board for a three-year term starting in June are: Marilyn Freed, Maria Leyva, Sharin Manes, Luci Messing, Michelle Smith, and Susan Sommer. Congratulations to all of the new, and returning, winners who will join the continuing officers and board members of the Board.

Delegates also approved the Constitution & Bylaw changes recommended by the Board.

The prestigious Les Reynolds Distinguished Senior Service Award was presented to this year's recipient, Julie Horwin, by Connie Wittig, Awards Committee Chairperson. Julie was cited for her many years of outstanding leadership and service to AEA-Retired and the community.

One of the highlights of the day was the breakout session where small groups to discussed their individual thoughts on three topics dealing with the pandemic. Members shared a myriad of ideas and reflections on such a monumental interruption in normal life.

The main event of the day featured three excellent guest speakers. Paul Matson (top right), Executive Director of the Arizona State Retirement System (ASRS), gave an in-depth update on the ASRS. A complete financial analysis and details of the newly adopted budget were given by Steve Linder, who was selected to fill the unexpired term of the AEA-Retired Treasurer who resigned recently.

LEGISLATIVE UPDATE BY LUCI MESSING



It has been a wild ride at the Legislature this session! As of this writing (May That means the Legislature will remain in session for a couple more weeks, perhaps into June. Arizona has an unprecedented surplus and everybody wants to spend it, making agreements more difficult. Now, lawmakers can't agree on how much money to give away. House Re-

publicans insist they have the votes to pass a flat tax proposal which would cut over \$1 billion from state revenues, but that proposal appears "dead on arrival" in the Senate. Unfortunately, the legislative majority's budget includes tax cuts and giveaways instead of properly funding public education.

Be ready to comment on the budget and make our voices heard.

AEA-Retired has done an amazing job in contacting legislators and the Governor. We can't let up now. The Legislature will not be in session that much longer.

Here's a quick legislative update:

SB1452 – The voucher expansion bill has not been scheduled for a vote in the House to date. The concern is if this bill makes it to the Governor's desk, he will sign it. Voters rejected voucher expansion when they voted down Prop 305. That didn't stop the majority from pushing this bill forward as well as others negatively impacting public education.

SB1532 – The Teacher Gag bill contains a last-minute amendment by Representative Michelle Udall would subject Arizona teachers to a \$5,000 fine if they allow classroom discussions on "controversial" topics such as racism or fail to give equal weight to both sides of "divisive" issues. Lawmakers advanced this amendment without any public input and passed it in the House the same day it was introduced. The majority party doesn't mind bending the rules when it suits them. At this time, it must pass the Senate before it goes on to the Governor. If signed, written and pushed by the American Heritage Foundation this bill will have a chilling effect on teachers' ability to do their jobs and further worsen our state's teacher shortage crisis.

SB1485 – PEVL Purge bill passed both chambers and was immediately signed by the Governor. There is absolutely no valid reason for this bill. Our elections were safe and secure. This may only be the beginning of some of the voter suppression bills that are being considered. We will continue to fight back against other voter suppression and anti-democracy bills being advanced at the state legislature, including HB2309, which criminalizes protest and SB1713, which would impose burdensome new ID requirements for those who vote by mail.

HB2035 - This is the revival of the vetoed legislation targeting LGBTQ students in public schools. The bill would prohibit 16th), budget discussions have just begun. student access to accurate health information and excludes LGBTQ students from curriculum just like failed original SB1456. Lawmakers used procedural tricks to turn HB2035 into a double opt-in mandate for sex education. It would ban age appropriate sex education before 5th grade and bans discussing gender identity and expression without parental consent. The majority party seems to have no respect for the Governor's veto of SB1456.

> Throughout this legislative session, we asked people to send **postcards** to the Governor and ask him to fully fund public education, and to veto all bills that will negatively impact our students, teachers, staff and communities. If, as you read this, the budget has not been passed, we encourage you to send another postcard. It's extremely important to express our concerns for appropriate education funding. Let the Governor know that we do not support tax cuts or tax giveaways when our schools are in dire need. As long as the Legislature is in session, we must continue to assert our position.

The **Senate's audit** did not meet the deadline of May 14th. The recount will continue once previously scheduled graduation ceremonies have been completed. It has been one fiasco after another. These lyrics come to mind, "Clowns to the left of me. Jokers to the right!" We are paying for it. Arizona continues to be the laughing stock on late night television. The Senate majority selected a company with no credentials or experience in conducting an election audit. Secretary of State Katie Hobbs and the Republican controlled Maricopa County Supervisors have gone on record about the lack of security and transparent procedures of those handling the ballots. The result has been and will be a total lack of creditability. Express your concern to the Governor about the stain on Arizona this "fraudit" has caused.




The Book Corner By Ann Meyers, Susan Sommer and Jan Nichols

VIP Update By Larry Wittig

In early Spring, members of the Valley Interfaith Council began going door to door in Maricopa County to help close the vaccination and public health gap. They began with Maryvale's poorest zip code, 85031. The mission was to increase the vaccination rate from 25 % rate, the 3rd lowest rate in the county. VIP partnered with St. Vincent de Paul Catholic Church, the Daughters of Charity and the Maricopa County Public Health Department to bring 1,600 vaccines into the community.

VIP organized a community walk on April 24th where leaders visited 402 homes. They left flyers and talked with 326 people. As a result of these conversations, 131 new people signed up for inoculations. An additional 1000 flyers were distributed in the area. Another community walk was held May 1st with similar results.
