6. Old Business	Proposal for change to AEA Retired Representation on AEA B.O.D. Pres. Linda Somo led this discussion by reviewing the background information documents including the survey from other states. She explained the need for the change using a slideshow prepared by AEA Secretary, Chris Mayer that showed how AEA Retired membership causes a misrepresentation of weighted votes representation on the AEA Board of Directors. Some suggestions made in regards to possible solutions were:  1) Shrink the ratio of weighted vote on the board  2) Leave things as they are  3) Add a 2nd retired board member from region 16  4) Change the arbitrary number that will cause growth of no. of retired members on AEA board from 4,000 to 3,000.  5) Weighted vote of AEA-Retired changed from 100 to 150 or 125 (because it, too, is an arbitrary assignment in the proposal.)  It was argued that each person who is a member should continue to be counted.  A member noted that because our numbers are taken from across the whole of AZ and, indeed, the U.S. and include those who will be members over a long period of time, while those who are Active, are geographically and time-bounded. This means that there will always be an advantage which will cause much larger numbers of members that will skew the ratio, or derived weight on the AEA Board of Directors, causing a misrepresentation of the one/person=one/vote.  There was continued discussion on the above two points.  It was moved to accept the proposal for change to AEA Retired Representation on AEA B.O.D. with the following change to Section 7: When growth of AEA Retired membership is 2000, another AEA-Retired member will be seated on the AEA Board. FAILED

Moved to accept the proposal for change to AEA Retired Representation on AEA B.O.D.; changing the required number of new members (Section 7) from 4,000 to 3,000. FAILED

Moved to accept the proposal, for change to AEA Retired Representation on AEA B.O.D. excepting the Section 7, to be discussed and changed at a later date. FAILED K. Campbell, K. Freed moved to table the discussion of change to AEA Retired Representation on AEA B.O.D. until January. Discussion will continue online. AEA Director Judy Moy, and Linda Somo will send out any new, updated explanations and information as they receive them. PASSED

It was noted that due to the change 3 years ago, from 2-year terms to 3-year terms, and all those who were eligible for another term, that there is no longer an overall staggered elections of board of directors. That is why there is only one seat open this year. It was suggested that in the near future a proposal be brought to the board which will allow for staggered terms. Question was also asked about why the very short timeline to get in

nomination form for AEA-DA. It was noted that originally date was created in order to allow for an election. However, no election has been necessary for longer than 6 years. ## AEA-Retired – AEA Board of Directors' Representation

Revised as of December 12, 2011

## Background

AEA and NEA governance representation is founded on the principle of one person-one vote so that all members have an equal voice within the association. The one person-one vote principle can be achieved using a variety of methods. For example, governance representation can be based on a fixed number of constituents. AEA uses that representation method for the AEA Delegate Assembly where members elect 1 delegate for every 25 members of their local constituency.

Because local association membership varies in size, governance representation for Regional Directors on the AEA Board of Directors uses a weighted vote method. Each Regional Director has a vote equal to the percentage of deviation from a statewide membership average. AEA Board of Director members who are elected by a statewide constituency have a weighted vote of 100. The AEA Compliance Review Committee, as charged in AEA Bylaws, Article II, Section 8, monitors the electoral regions to assure compliance with the one person-one vote principle.

As the weighted vote range widens, representation becomes more unbalanced causing constituency groups to be over or under represented. AEA-Retired membership has grown steadily over the last 10 years while at the same time AEA active membership has declined. This has resulted in the weighted vote calculation on the AEA Board of Directors significantly favoring the retired membership constituency and diminishing the weighted vote of many active membership constituencies, such as rural or ESP at-large.

Specifically, the AEA Bylaws require the total active and retired membership be divided by the number of regional directors to establish the average number of members for each director. Each region's membership is then divided by that average to determine a region's weighted vote. Because AEA-Retired membership is significantly greater than any other local association, it skews the calculation of the average. Using today's membership figures, the weighted vote range on the AEA Board of Directors is a low of 49 for rural, active members to a high of 253 for retired members.

NEA's Constitution, Article V, Section 1, defines the composition of the NEA Board of Directors and sets a fixed number of directors from the retired membership category. In contrast, AEA's Constitution instead structures all retired members into 1 governance region, Region 16.

The AEA Officers recognize this representation imbalance and want to jointly develop a long-term solution with AEA-Retired.

## DRAFT

## Proposed AEA Constitution Amendment

#### ARTICLE III - THE BOARD OF DIRECTORS

Composition

Section 1. The Board of Directors shall consist of the officers of the Association, the State Director(s) of the National Education Association, THE RETIRED DIRECTOR(S), the Regional Directors as provided for by Article III, Section 6, of the Constitution, at-large directors of the National Education Association from Arizona, and Executive Committee members of the National Education Association from Arizona. NEA at-large directors and Executive Committee members shall have the right to speak, but shall not have the right to make motions and shall not have the right to vote.

Qualifications

Section 2. Each member of the Board of Directors shall be an active or retired member of the Arizona Education Association.

Authority

Section 3. The Board of Directors shall be:

a. charged with general management of the affairs of the Association and, in the absence of specific provisions otherwise, shall determine the policies of the Association between annual meetings of the Delegate Assembly.

b. able to recommend a boycott of companies or products to the Delegate Assembly. A

majority vote of the Delegate Assembly shall implement the boycott.

Recall

Section 4. Members of the Board of Directors and Alternate Directors of the Association shall b subject to recall from their respective offices by the constituency which elected them as provided by Article XIII of the Constitution.

Regional Directors

Section 5. At each annual meeting of the Delegate Assembly, the delegates shall elect Regional Directors and one Alternate Director for each region as needed from the membership of the Association as designated in Section 6 below; the Alternate Directors must be elected in accordance with regulations set for election of AEA Directors. Elected Regional Directors shall serve for a term of three (3) years or until their successors shall be elected. In no case shall such members serve more than two (2) consecutive terms as a Director or Alternate Director. Alternate Directors shall serve for a term of three (3) years. The election of Alternate Directors shall coincide with the election of the Regional Director position that the Alternate Director would be filling. Each Regional Director and Alternate Director shall be a member from the region of the Association in which he/she serves and shall be elected by the delegates of his/her region. Prior to a Board meeting, any director unable to attend shall inform the President that the Alternate Director will serve in his/her place. Once seated by the President, Alternate Directors shall have the right to vote and otherwise participate. Each Director shall enter upon his/her official duties at the same time as other elected officers.

Regional Elections

Section 6. A region shall hold an election for Regional Director when realignment of regions has caused a fifty percent (50%) or more change in the number of local associations in that region or when that Director's local has been moved.

RETIRED DIRECTOR

Section 5 7. AT THE ANNUAL MEETING OF THE DELEGATE ASSEMBLY, THE RETIRED DELEGATES SHALL ELECT A RETIRED DIRECTOR FOR AND FROM THE RETIRED MEMBERSHIP. ONE RETIRED DIRECTOR WILL BE ELECTED FOR EVERY 4,000 RETIRED MEMBERS OR PORTION THEREOF. RETIRED MEMBERSHIP SHALL BE BASED UPON THE NUMBER OF AEA RETIRED MEMBERS AS OF JANUARY 15. ELECTED RETIRED DIRECTOR(S) SHALL SERVE FOR A TERM OF THREE (3) YEARS OR UNTIL THEIR SUCCESSORS SHALL BE ELECTED. IN NO CASE SHALL SUCH MEMBERS SERVE MORE THAN TWO (2)

## Frequently Asked Questions about the Design Concept

## AEA Board of Directors' Representation

- 1. What is the representation on the NEA Board of Directors for retired members?

  The **NEA Constitution, Article V., Section 1. Composition**, states that the NEA Board of Directors shall consist of ... "six (6) directors for the Retired membership of the Association..."
- Will AEA-Retired still have a director on the AEA Board of Directors?
   Yes. AEA-Retired would have a director on the AEA Board of Directors that would represent retired membership and only be elected by AEA-Retired members at Delegate Assembly.
- 3. Will AEA-Retired still elect an alternate director to serve in the absence of the AEA-Retired Director at an AEA Board of Directors' meeting?
  Yes. AEA-Retired would continue to elect an Alternate Director that would serve in the absence of the AEA-Retired Director.
- 4. How can AEA-Retired elect more than one retired director for the AEA Board of Directors?

  AEA-Retired would elect one retired director for every 4,000 AEA-Retired members or portion thereof. Retired membership shall be based upon the number of AEA-Retired members as of January 15.
- Will the Retired Director still have the same rights and standing as other directors?
   Yes. The Retired Director will have all the same rights, privileges, and standing as all directors on the AEA Board of Directors.
- 6. How does this change help the AEA Board of Directors? This begins to balance representation among all of our members. The Retired Director would have a weighted vote of 100, the same as an AEA Officer, NEA State Director, ESP At-Large Director, or Ethnic Minority At-Large Director. Without retired membership in the weighted vote calculation, the weighted vote range narrows to 57-155 without any further adjustments to regional representation.
- 7. How does this change help AEA's requirement for compliance with NEA guidelines?
  Using the weighted vote method for the AEA Board of Directors does comply with NEA Standards of Affiliation. However, the more narrow the range of weighted votes, the more balanced the representation becomes among all constituents.
- 8. Is this an attempt to silence AEA-Retired's voice on the AEA Board of Directors?

  No. This is a long-term solution to balance representation on the AEA Board of Directors and give all membership constituencies a fair and equal voice.
- Does this change affect funding for the AEA-Retired Director?
   No. Funding, privileges, and responsibilities for all members of the AEA Board of Directors are defined in AEA Board Policy and the Retired Director would be governed by those policies just as all other directors.
- membership loss and cost effectiveness?

  Yes. The Compliance Review Committee is reviewing the regional director representation for the AEA Board of Directors. They are required to use January 15, 2012 membership figures to determine their final recommendation to Delegate Assembly. The number of regional directors on the AEA Board of Directors will be reduced as a direct result of AEA's membership loss. The number of directors and resulting local association assignments are still being evaluated.

#### ARTICLE IV - NOMINATION AND ELECTION

Time of Election

Section 1. Officers, Regional Directors, **RETIRED DIRECTORS**, Alternate Directors, **ALTERNATE RETIRED DIRECTOR**, State Directors of the National Education Association, Alternate State Directors of the National Education Association, and members-at-large shall be elected at the annual meeting of the Delegate Assembly.

#### Nomination

Section 2. Candidates seeking election to a position as an AEA Officer, State Director of the National Education Association, Alternate State Director of the National Education Association and any individual who may wish to seek an AEA officer position that could become available (vacant) through the election of a current AEA officer to a different AEA officer position, shall file in writing a statement of candidacy with the AEA Executive Director...

Nominations for Regional Directors, RETIRED DIRECTORS, Alternate Directors, ALTERNATE RETIRED DIRECTOR, and Members-at-Large shall be made from the floor of the Delegate Assembly on the first day of the annual meeting. Candidates for officers, state directors of the National Education Association, and Alternate State Directors of the National Education Association that complied with the March 1 deadline for candidate filing shall complete the nominations process by being nominated from the floor of the Delegate Assembly on the first day of the annual meeting. A candidate for an At-Large Director shall indicate for which position he/she is a candidate. If the number of candidates nominated equals the number of positions to be filled, the chair shall declare such candidates elected except for at-large positions. If, after a regular election, the number of candidates for the member-at-large positions nominated equals or is less than the number of positions to be filled, the chairperson will declare those candidates elected. A second election will be held for any remaining positions.



# 2011 Program Goals

## Membership Growth

The Arizona Alliance for Retired Americans focused on increasing the organization's visibility among community groups and building a membership base, including expanding the state-sustaining membership program, and union and community affiliates. In 2011, the AARA gained 5,000 new members, raising our statewide membership to over 40,000.

The AARA has been tremendously successful at increasing visibility within the community and

establishing the organization as a resource for older adult issues. The AARA was invited to participate in a White House Roundtable Discussion on Senior Issues. The AARA Education Fund received a grant from the Wider Opportunities for Women which funded a pilot program for Grandparents Raising Grandchildren. The program brought together likely and unlikely partners to a state-wide taskforce focusing on Grandparents Raising Grandchildren. The AARA continues to work on the Maricopa County Kinship Care Coalition, and has been invited to speak at the 2012 Grandparent Summit.



## **Program Development**

The AARA has a long history of working on economic security and intergenerational issues in Arizona. The organization has been at the forefront of the Social Security and Medicare debate. Sustaining these critical economic security programs is not just securing the future of retirees, but securing the economic future for all generations and the communities in which they live.

Throughout the year, the AARA implemented an aggressive campaign designed to protect Health Care, Social Security, Medicare, and Medicaid. This campaign was divided into several components:

- 1. Exemplify effective communication (letter-to-the-editor campaigns, editorials, Facebook, Twitter, Website Updates, Blog Posts, Email Updates)
- 2. Organize Rallies and Protests around the issues
- 3. Host Educational Events for the general public


# 2011 Budget
