AEA Board info -- Ken Freed /Luci Messing-- March AEA board meeting highlights: meet at the Capitol this Wednesday afternoon, overall membership gradually moving up, loss of 31 retired members overall this year. Negotiations and ASO has ratified the agreement with all groups. Some meetings will be held in person and some virtual next year with the AEA board. Hiring of new exec director hopefully onsite by end of July/August.
