1. Call to Order at 10:05 by President Somo

- 2. Approval of Agenda (Zuniga/Ramage-White) Approved
- 3. Approval of the minutes of the March Meeting (Mehok/Linder) Approved
- 4. Arizona Retirement Security Coalition Horwin reported that the coalition is forming a political arm. The preference to chair this group is a retired, female educator. Currently, AEA is the largest member of the coalition. Ramos shared the situation with the Phoenix first responders and their negotiations with the city. The firefighters have accepted a reduction in compensation, while the police officers have refused and hence have been imposed upon. Also, shared was the potential ballot initiative entitled "Pension reform and anti-spiking, which would be the toe in the door of moving from a defined benefit plan to a defined contribution plan. The initial cost implications are an increase of \$400,000 which will have to be paid by Phoenix taxpayers. In addition to this additional tax burden, pensions are diminished.

President Somo-Thanked all who worked at making the Annual Meeting a rousing success. Shared that retirees donated close to \$10,000 between the NEA Fund and the AEA Fund.

Thanked the Board for her going away present. She is currently researching what new computer to purchase.

Thanked Stephenson and Ramos for doing a Pre-Retirement Workshop. This is the last of the year during which 9 were conducted.

Thanks to Mehok and Matteson for representing AEA_R at recent retirement parties. The President will be attending two more on Tuesday evening.

Announce the attendees at the NEA-R Annual Meeting. Currently K. Freed, M. Freed, K. Campbell, Putman, Moy, Barlow, Stephenson, Mehok and Coleman plan on attending. Also, J. Campbell will be their as a representative on the NEA Board. The three elected representatives are Somo, Horwin and Matteson.

AEA-Retired Day at the Capital is 3/12 and 3/19

Offered special thanks to those members who are leaving the Board. These include: K. Campbell, Aber, Zuniga and Michels.

Vice –**President Austin**-Shared a **written report** delineating our success at the annual meeting. Special thanks to Chris Mayer, Mike Aicone, Liz Hendrickson, Annji Craig-Wooten and all that made it another outstanding event.

Liaison Aicone-Indicated that the payroll deducts option is beginning to work. Approximately 100 people have recently joined using this option.

The assessment letter has generated \$9,318 from 763 respondents, thus far. The IMPACT fund currently has \$4,824.

AEA Director Moy-Though not able to be in attendance, she shared the April 25 agenda and sent a personal note to the Board. from the AEA Board

NEA Director Campbell-Discussed the NEA budget, which had been discussed at the most recent NEA Board meeting. Seemed to indicate that some of the Leadership/management priorities are misplaced, and should be revisited. The Board moved some of the funding back to the Student Program though that program seemed to take a larger hit than others. Shared some of the expenses that are incurred by the 9 member Executive Committee.

AFT/NEA state mergers were discussed. The elimination of a cap will be forthcoming.

Shared that between he and NEA Director J. Freed they visited all 11 Arizona members of Congress. No sit-in at Senator McCain's office was necessary.

- 9. AEA-Retired Elections Chair Linder provided a **written report** of the election results at the Annual Meeting. Additionally, he reported that we exceeded our ethnic representation goal. The goal was 11% and we attained 19%.
- 10. AEA Fund Council report was delivered by Coleman and Somo. Duvall, Rotolinni, and Garcia have been "Recommended" to the membership. The Council will consider Goddard and Holman on Saturday. The Council will also consider recommendations of "Friendly" incumbents as well as Chair recommendations of state legislators.
