She is also on the AEA Racial equity and social justice task force, reviewing language in AEA resolutions and planning PD for AEA members.

Ellie Perez-Pawlowski (AEA Liaison)— Ellie introduced Brendan Foland (new govt. relations director) was House Democratic Legislative staff support prior to joining AEA last week. School board races 2022 -50 locals involved, Independent Redistricting commission in process, elect Democratic governor, AZ primary Aug. 2nd this year, work on school board elections.

Possible Hot topics – retaliation against school boards, make school board elections partisan, curriculum mandates, expenditure cuts to schools, funding cuts (transportation), investigate school boards – withhold classroom site funds possible legislative interests, attacks on the pension system, attack on groups that support LGBT and BIPOC groups in schools.
