#### Attend AEA-Retired Annual Meeting April 24th, 2015

Mark your calendar and plan to join your colleagues for a fun-filled, informative day at the  $27^{\text{th}}$  AEA-Retired Annual Meeting, which will be held again at the Wigwam Resort in Litchfield Park, on Friday, April 24, 2015 from 9:30 – 3:30. For those who wish to be a delegate, the AEA Delegate Assembly will follow, beginning at 6:00 PM on April 24, and continuing on Saturday, April 25.

All AEA-Retired members and their guests are invited to attend the Annual Meeting. Members who wish to also be delegates with voting rights to elect AEA-Retired officers and Board members, will be delegates to the AEA Delegate assembly as well. All AEA-Retired Delegates will be funded for half the cost of a doubleoccupancy room for the night of April 24<sup>th</sup> and be reimbursed for mileage that exceeds 100 miles one way.

Included in this issue of *The Conduit* on page 5 is a nomination form to be a delegate to both the AEA-Retired Annual Meeting and AEA Delegate Assembly. In order to participate in the election of AEA-Retired officers and Executive board openings, members must be delegates. Delegates will be electing a Vice President and five Representatives-at-Large. If you are interested in running for one of these positions, the nomination form is included on page 5 along with the nomination form for being a delegate.

AEA-Retired will be allotted 85 delegates to Delegate Assembly, making our "local" the largest delegation to attend and a major player. If there are fewer nominations than allotted slots, all nominees will automatically be certified as delegates. If more nominations are received than positions available, then voting will take place electronically in February & March. All nomination forms for delegate positions or AEA-Retired Board must be received by Monday, February 9<sup>th</sup>.

One of the highlights of each AEA-Retired Annual Meeting is the presentation of the **Les Reynolds Distinguished Senior Service Award.** Please use the information on page 6 to nominate an AEA-retired member worthy of receiving this special award.

# War on public pensions continues

Phoenix voters blasted Prop 487, a proposition that would have forced the city to close its defined benefit pension system and move new employees into an inferior, riskier and more costly 401k style defined contribution plan. The election outcome was a major victory in the battle to protect all of Arizona's public pension plans. Prop. 487 was placed on the ballot by the Arizona Free Enterprise Club. This "dark money" group spent \$1.43 million, hoping to make Phoenix the first major sized city to downgrade public employee pensions. A million dollars of that funding was tied to Texas billionaire and former Enron hedge fund manager John Arnold. A coalition of public employee groups, including NEA, and AEA, provided volunteers and political action funds to defeat 487. Thank you to all of our members who helped with this effort.

Your Arizona State Retirement System remains the "good pension" among Arizona's retirement systems. Currently funded at about 76%, ASRS continues to recover from the economic turmoil of the last several years and is slowly returning to the 80% funding level considered good by today's standards. Now that statewide elections are over, we have a better picture of what AEA Retired will face in the up-coming Arizona legislative session. The balance of power remains unchanged in the House and Senate, as AEA was successful in electing and returning some pension friendly legislators to office. They will need our help throughout the session as many of the pension attacks we saw last year will be back. Please spread the news about our efforts and encourage others to join us. The poor performance of the Public Safety Personnel Retirement System will continue to put pressure on Arizona to make public pension changes. This issue cuts both ways for ASRS members, as court decisions have recognized our constitutional protections, but those protections also block needed changes to PSPRS. How do we drop our shields to allow one pension system to be fixed, without making ASRS members a vulnerable target for those who want to reduce our benefits? It may require the skills of a starship captain like James T. Kirk for us to navigate that very perilous journey. Stay tuned for future episodes.

#### Possible data breach could affect 44,000 ASRS retirees

In October, ASRS became aware of a possible data breach that could potentially affect up to 44,000 retirees who purchase their dental insurance through ASRS. Retirees who are currently enrolled in ASRS dental insurance plans provided by Assurant were notified by mail of the situation.

To protect members, ASRS will provide twelve months of services from AllClear ID, which is the company that covers customers who may have been affected by the security breach at Home Depot. Benefits include credit monitoring and a \$1 million identity theft insurance policy.

Those who are enrolled with Assurant and have received a letter from ASRS regarding this issue can call AllClear ID at 1-800-731-6012, if there is a problem.

# Let's deal with the facts, not an agenda!



We've all seen the steady stream of headlines and heard the sound bites declaring public pension systems a disaster, unsustainable or a failure. To the average citizen these are examples of bloated entitlement programs run amuck. For public retirees, like you and me, these reports portray a nightmare scenario in which our retirement security is in jeopardy. However, to the leadership of AEA-Retired with direct knowledge of our ASRS public retirement system, these reports are most often an inaccurate and highly misleading attack. Often times the reports broadly apply problems that may exist in other retirement systems in our state – or in other states - as if those same alleged problems also exist with the ASRS.

#### It's important to note that the average ASRS pension amount is \$22,000/year. This fact can't be ignored!

Many of the organizations producing reports that attack our pension system are well known for their opposition to defined benefit pension plans, as well as their hostility toward public employees. The same applies to the columnists and talking heads who regurgitate these unfounded reports as if they're facts.

Thankfully, recent "reforms" have tightened up already well-run public retirement systems by closing potential loopholes and modernizing retirement benefits. Arizona's ASRS public pension now serves as a national model for best practice and oversight. I respect anybody's "Opinion" on these issues, but such opinion should be based on all relevant facts not just facts that support the "Opinion". Otherwise it's not an "Opinion" it's an Agenda!

### So why am I bringing this up now after we successfully beat Prop. 487 in November?

The pension attacks promise to return this year in the state legislature, and there are threats that legislators will attempt to break, through referendum, the constitutional protections that we worked so hard to pass at the ballot over 15 years ago. I ask that you stay tuned to news from AEA-Retired in order that when we need your help to maintain our protected pensions, we can call on you. For my part, I promise to keep you informed via articles in <u>The Conduit</u>, the online E-Newsletter and our Facebook Page.

#### Social Security and Medicare

As pensioners, and as an organization of retirees that maintains a focus on related advocacy issues, we are committed to understanding the relevant issues of health care, and its availability and impact on seniors. As such, we are proponents of maintaining Medicare and Social Security and advocating for continuation of the provisions of these programs. The 2014 election is over and, though the results of the statewide races were quite disappointing, there were a number of positive outcomes. The Phoenix pension reform proposition (487) was defeated soundly. In addition, the balance of power in the state legislature remains basically the same which means we should be able to work with our representatives to protect our pensions.

Also, the majority of our school districts passed their overrides and were able to elect pro public education governing board members. We need to take the opportunity to celebrate the victories.

Thanks go out to the many members who participated in election events and activities.

However, our work is not over. It is more important than ever that we remain active and vigilant in monitoring the new legislature. It is entirely possible that there could be another attempt to attack our pensions and we must be prepared to respond.

### **Trusting Seniors still targeted for many types of scams**

Scammers are constantly creating new ways to target Senior Citizens, which means we have to always be vigilant. Some of the most recent include:

- A phone call from an "official" of the local court system saying that you are guilty of missing a call to jury duty and requiring you to provide a credit card number over the phone to pay for your "fine"
- A phone call from the IRS that you didn't pay enough in your taxes and to avoid further penalties you need to provide a credit card number to pay the appropriate amount, or risk being "fined", "jailed", etc.
- You receive a call to expect a delivery (flowers, package, etc.) and schedule a time to be home; when the delivery arrives, you are asked to sign for it and pay a small fee around \$3.00, which can only be paid by a credit card; the scammer then has your credit card number and your signature.

To avoid being taken advantage of, remember that NO official government agency, like the IRS, Social Security, or Medicare, will contact you by phone or email, or ask for credit card information. Only the US mail is used by government agencies to notify individuals of official business. And with the holiday season in full swing, be especially careful of any possible holiday related scams.
