Messing indicated that the one thing that the Governor dislikes is being contacted by constituents. That being the case, she asked that we give the Governor a call and "Bug" him about those things which are clearly anti **public** education. To assist in that endeavor, a list of phone numbers was provided for the legislators and the Governor.

Jan Nichols led a discussion of the latest bills in the state legislature. Members were reminded of the AEA Delegate Assembly and the AEA-Retired Annual Meeting. <u>Mesa (Somo)</u>-The Next meeting is May 10 at 63 East Main Street, Mesa, on the 8th floor of the MPS Building, 10:45, where the discussion will be about a proposed 28th Amendment to the U.S. Constitution. This amendment, would simply state that "Corporations are not people. Money is not speech." Slogans will be stamped on individuals' money, such as "Not to be used for paying politicians."
