The Arizona State Retirement System: Awards, Changes and the Permanent Benefit Increase

State System honored as "one of the best"

The non-profit Pew Center on the States recently released a study on state retirement systems. The report listed Arizona as a "Top Performer" in responsible funding of its pension plans and future retiree health costs. The study listed Arizona as "one of just six states to fully fund the bill coming due for non-pension obligations." ASRS Director Paul Matson said, "Our members can have confidence that the benefits they have worked for will be there when they retire." Proposed Legislative changes to the plan

The ASRS has again proposed legislative changes to the plan design that they believe will

make the fund stronger and decrease contribution rates. The changes would only affect members entering the system after July 1, 2008. The following are some of the changes in House Bill 2062:

- *Change the calculation of a member's average monthly salary from the highest 3 years to the highest 5 years
- *Raise the points for Normal Retirement from 80 to 85
- *Limit a member, who terminates employment after five or more years, to a refund of only 25% of their employer's contribution.

Other pieces of legislation concerning ASRS have been introduced and will continue to be monitored by your AEA-Retired representatives.

Return to Work

As this newsletter goes to print, the ASRS is meeting on the issue of Return to Work and its effect on the status of the fund and contribution rates. AEA-Retired continues to support an educator's right to return to work, but not at the expense of their working colleagues and to the detriment of their own retirement fund.

Popping up and down

A new law affecting only those who retire after July 1, 2008 will limit the number of times you can change from a joint survivor or period-certain option to a straight-life annuity payout as a result of changing life circumstances. The unrestricted practice known as "popping up or

popping down" was creating an unfunded liability to the overall fund which had to be paid through higher contribution rates of other members.

Lower rate for 2008-2009

In November, the ASRS Board announced a lower contribution rate effective July 1, 2008. The ASRS has been under pressure to reverse a five-year trend of increasing contribution rates. The rate will drop from 9.6 to 9.45 as a result of strong investment performance in 2006-07.

The Permanent Benefit increase and the 13th check

Despite fund earnings of 17.8% in 2006-07, the numbers were not strong enough to trigger a Permanent Benefit Increase. Earnings in excess of 8% generate funds used for a PBI. The formula for determining the PBI includes a device called "10-year smoothing" that averages earnings over 10 years. Those 10 years include some bad years between 2000 to 2003 and some bad quarters in late 2007. Your AEA-Retired representatives have expressed concern about the effect of using a 10-year smoothing formula on the PBI. The ASRS changed from 5-year smoothing to 10-year smoothing to help stabilize the fund status and contribution rates.

The ASRS Board also decided not to issue an addition to the 13th check in 2007 to those members who are in the old retirement system. The Board decided that despite a funded status of 115.87%, it would be prudent to retain the current surplus to reduce the likelihood of benefit reductions in the future.

When I retired in 1999, we had no mentor program. We now have an expanded mentoring program. It is now called Arizona IMPACT. AEA-Retired: News and Views You Can Use

Coalition of associations monitors Arizona State Retirement System (ASRS); makes recommendations for legislation and positions

The Coalition of Arizona State Retiree Associations met in November, chaired by **Bob Bloom** and **John Campbell**. The purpose of this group is to maintain the integrity of ASRS and its \$28 billion in assets. Discussion included ideas for the development of procedures and policies for dealing with the negative aspects of retirees returning to work. The group supported ASRS efforts to fine tune legislation, especially items regarding revision of the Defined Benefit Plan. Also, revision of the 10-year cycle for calculating contribution rates to the retirement fund received strong support. Although equity legislation will probably not be re-submitted this time due to the unpromising budget situation, the group will keep the issue alive.

The Coalition was formed in 1998 to pass Proposition 100 (Pension Protection Initiative). The Proposition placed the Arizona Public Retirement Systems under the protection of the Arizona Constitution. Until this passage, the fund was protected by statute only and statutes can be changed by any legislature. This effort was supported by AEA at its 1997 Delegate Assembly. The original members of the Coalition were AEA, AEA-Retired, AASRA, AFSME, ASURA, NAURA, UARA, FOP, PSRS and CORP. Bob Bloom was the first chair and remains co-chair. The Coalition meets once each year and discusses legislation and positions we might take. Members monitor the legislature and ASRS.

If you do not get the chance to participate, you still can help the cause of literacy by going to the NEA website to get information, materials and ideas about how to help kids get reading.


