AEA launches online voting; new system is fast, easy, and secure

February 12 marked the beginning of a new system of voting in association elections which could lead to greater participation by members in electing their leaders. It eliminates the need for local associations to conduct elections on behalf of AEA, and it also eliminates the need for postage to mail ballots back. The process is incredibly simple. Voting deadline is midnight, April 10.



Here's how to vote. Go to the AEA web site at www.arizonaea.org and click on NEA-RA Vote Online, located under Resources on the right side of the page. Login to the safe and secure voting area. Your username is your first initial and full last name (no spaces, commas, or apostrophes). For example, Frank Bing would use FBing for the username. Your password is the last four digits of your social security number. Once you are logged in, you are eligible to vote on any ballot listed for you. Click on the ballot and follow the instructions. You will have a chance to review your choices before you click on the large VOTE button to cast your vote. You will then be given the opportunity to print out a copy of your com-

pleted ballot. Nothing could be easier.

LEGISLATIVE UPDATE BY JULIE-HORWIN. LEGISLATIVE CHAIR

In the November 2008 election, 73% of Arizona voters age 50 or older voted! This sends a clear message to our legislators at the State Capitol that Arizona's retired teachers are not here just to be served but are ready to serve those who need our help.

Our successes on individual legislation and campaigns, such as helping to defeat the Proposition 101 "medical choice" ballot initiative in 2008, are relevant to all the residents of Arizona as well as ensuring the well-being of retired education employees. Our victories also imply, dear readers, that we need to begin talking in earnest to our fellow retirees who vote. We need to make certain that we have our common issues well articulated so that our votes send a clear message: we want our legislative issues to be heard, to be taken seriously, and to be

- * Advocate the appropriate funding of education in the schools of Arizona. Each of us is still connected in some way to a child or children in Arizona. We did not resign from our profession; we only resigned from our position.

* Advocate for the best "cost of living increase" that will keep retirement both dignified and realistic.

our AEA-Retired representative on the ASRS Health Committee, report each month on any issues/bills/initiatives that are being discussed.



ASRS Advances Legislative Changes To "Return To Work"

- 1. Changing the calculation of a member's average monthly salary from the highest 3 years to the highest 5 years.
- Raising the points for Normal 2. Retirement from 80 to 85

3. Limiting a member who terminates employment after five or more years to a refund of only 25% of their employer's contribution.

These changes would apply **only** to new employees hired after the effective date of the legislation. AEA has not yet taken a position on the changes but is studying them and gathering information.

The ASRS has also introduced legislation making some changes to the original "Return To Work" law. These changes attempt to address the liabilities that are being created in the fund by retirees returning to work through a private contractor. ASRS hopes to mitigate the problem by charging employers an Alternative Contribution Rate. mid, and small) and all styles (value, core, At this time the bill's future is uncertain. Both AEA and AEA-Retired have been very involved in negotiating the language in this bill because we have an interest in maintaining a healthy defined benefit retirement system. That said, AEA has not taken a position on this bill and continues to work for legislation that is in the best interest of all members.

Third Quarter Total Fund Review. ASRS financial consultant, Terry Dennison, prepared a report that looked at the numbers through November 30, 2008. He told the Board that "the financial markets have been devastated and the impact is global." "It took us 25 years to get into this mess; it will take a long time to get out." The market dropped 49.2% on March 24, 2000. It took 1,826 days (5 years) to get back to where it was when it started. Dennison reminded the Board that "if you lose 50% of market value, you need a 100% return to get your money back." As of December 19, we had gotten 20% back.

Despite being well diversified, ASRS investments were down across all caps (large, and growth). ASRS actually was more conservative than most funds and as a result may fare better than funds such as California's CALPERS, which had recently invested heavily in real estate. Performance for the fund was -8.2% for the quarter and -16.3% for the year. The fund has approximately \$19.5 billion as of November 30, 2008.

In December, the ASRS Board received a

als, we can do little to con-



Saving Money (we all want to); generic meds at Costco incredibly inexpensive

A little while back, I received an e-mail from a friend advising me to check out medication prices at Costco.com. When I did, I was astounded to find that I can save over \$30 on *each* of my generic medications over what I've been paying for three-month supplies of maintenance meds through Pacificare! For me, that means a savings of \$600+

a year. I immediately decided that this was too good not to share with *Conduit* readers, especially those who have Medicare, Part D, and get caught paying full price after they fall into the "donut hole."

To check out what *you* can save, log on to www.Costco.com and click on the pharmacy link. Have your prescription bottles with you when you go online. You can then see right on the screen what your generic meds will cost you. If you decide to switch your prescriptions, you can do so by mail, or if you live close enough, you may just walk in to a Costco pharmacy. By law, you do not have to be a Costco member to use the pharmacy.

There are other places which offer reduced prices for generics, but some we cannot mention because of their virulent anti–union stances.
