9. Officers' Reports

President Horwin-provided us with a written report including information about payday loans press conference, lobby day on March 16, AEA-Retired Grant meeting directly after this meeting, Voting for NEA-RA is now online, AEA Summer Institute, AFSCME and ASRS threat, Prop 123 Rally in Chandler, AEA & LFC partnership Candidate Training.

Vice-President Austin-Report on the Annual Meeting. In a written report, Austin shared information about the DA including that the lunch is \$35, which is more than what we have chosen to charge. She reminded the Board of their commitment to bring wrapped and unwrapped gifts. A job list was circulated for each of us to select jobs at the Annual Meeting. Austin asked us to determine the theme of the event. "Unite, Inspire, Lead, Together We Can," was the group's choice.

Liaison Sleeper-Shared that AEA is concentrating on Prop 123 and the upcoming Delegate Assembly. Also, the AEA computer system was "infected" with a virus that would have locked them out of their computers had it not been realized and combatted. This was handled in 12 minutes.

AEA Director Moy-Provided the minutes of the most recent AEA Board meeting.

NEA Director J. Campbell-no report.

NEA's Todd Crenshaw-provided a written report indicating that 122 NEA members took part in the most recent M.O.R.E. Regional meetings, with 75% signing up to take part in the upcoming Arizona election. He also shared that he is now getting requests from other states to join the movement due to the publicity Arizona has garnered.

10. ASRS

Chairperson Ramos provided a written report and emphasized the bills of which we need to be most concerned. Thanked Linder and K. Freed for conducting a retirement workshop in the South. Ramos also shared that one of the fund managers has taken a job elsewhere, which is a huge loss for the ASRS.

11. AEA-Retired Elections

Chairperson Ramage-White provided the Board with a written report that details who has been nominated to run for the AEA-Retired Board and as delegates to the Delegate Assembly. She shared that there are currently 8 people seeking the 6 at-large seats, 1 person seeking the secretary position, and 80 people who have submitted pledge-to-serve forms to serve as delegates. As a result, there is no delegate election necessary and the delegates have therefore been elected to serve. Nominations will also be taken from the floor of the Annual Meeting.

12. Political Action and Election Update

Chairpersons Matteson and Wittig provided a written report and thanked people for their attendance at the Legislature. The Board was reminded of the March 16 lobby day. It was shared that the pro Prop 123 campaign has collected \$1.4M. Also, a list of the 8 Members of the House who have been supportive of education and children was provided.

- Southeast Arizona (Rosen) The chapter met on January 28 at the Manda Le Restaurant. The <u>next meeting is in March 11</u> at Ricardo's Restaurant in Hereford, AZ. The final meeting of the year will be the first week of May, with details to be determined.
