**Joe Thomas**— (AEA President). Invest in Ed updates — initiative launched and filed, no petitions yet until wording is reviewed in about a month, these are the main areas of focus:

3.5% income tax surcharge taxable income \$250K indiv, \$500K couple, \$15 per day, raises \$800-900 million annually,would go to: 50% non-admin salaries, 25% classified compensation, 25% — 10% fund teacher mentoring system, 12% grant based CTE/Gifted/Counselors/at risk for 9th-12th grade only, 3% fund towards AZ Teachers Academy, Voter protected money Currently 1800 classrooms unfilled by certified educators. Will follow up with more info and petitions soon!
